Introduced by Assembly Member Arambula

February 11, 2021

An act to amend Section 422.56 of the Penal Code, relating to hate crimes.

LEGISLATIVE COUNSEL'S DIGEST

AB 600, as amended, Arambula. Hate crimes: immigration status.

Existing law makes an act punishable as a hate crime if it is a criminal act committed, in whole or in part, because of an actual or perceived characteristic of the victim relating to the victim's disability, gender, nationality, race or ethnicity, religion, sexual orientation, or association with a person or group with one or more of these actual or perceived characteristics. Existing law defines "nationality" for this purpose to include citizenship, country of origin, and national origin. Under existing law, a person who commits a crime that is a hate crime is required to receive an enhanced sentence.

This bill would expand the definition of nationality to include immigration status, thereby making it a hate crime to commit a criminal act, in whole or in part, because of the victim's actual or perceived immigration status. By expanding the scope of an enhancement, this bill would impose a state-mandated local program. This bill would also make technical, conforming changes.

The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that no reimbursement is required by this act for a specified reason.

The people of the State of California do enact as follows:

1 SECTION 1. Section 422.56 of the Penal Code is amended to
2 read:

3 422.56. For purposes of this title, the following definitions
4 shall apply:

5 (a) "Association with a person or group with one or more of
6 these actual or perceived characteristics" includes advocacy for,
7 identification with, or being on the premises owned or rented by,
8 or adjacent to, any of the following: a community center,
9 educational facility, family, individual, office, meeting hall, place
10 of worship, private institution, public agency, library, or other
11 entity, group, or person that has, or is identified with people who
12 have, one or more of the characteristics listed in the definition of
13 "hate crime" under paragraphs (1) to (6), inclusive, of subdivision
14 (a) of Section 422.55.

15 (b) "Disability" includes mental disability and physical
16 disability, as defined in Section 12926 of the Government Code,
17 regardless of whether those disabilities are temporary, permanent,
18 congenital, or acquired by heredity, accident, injury, advanced
19 age, or illness. This definition is declaratory of existing law.

20 (c) "Gender" means sex, and includes a person's gender identity
21 and gender expression. "Gender expression" means a person's
22 gender-related appearance and behavior regardless of whether it
23 is stereotypically associated with the person's assigned sex at birth.

24 (d) "In whole or in part because of" means that the bias
25 motivation must be a cause in fact of the offense, whether or not
26 other causes also exist. When multiple concurrent motives exist,
27 the prohibited bias must be a substantial factor in bringing about
28 the particular result. There is no requirement that the bias be a
29 main factor, or that the crime would not have been committed but
30 for the actual or perceived characteristic. This subdivision does
31 not constitute a change in, but is declaratory of, existing law under
32 *In re M.S.* (1995) 10 Cal.4th 698 and *People v. Superior Court*
33 (*Aishman*) (1995) 10 Cal.4th 735.

1 (e) “Nationality” includes citizenship, country of origin,
2 immigration status, and national origin. *This definition is*
3 *declaratory of existing law.*

4 (f) “Race or ethnicity” includes ancestry, color, and ethnic
5 background.

6 (g) “Religion” includes all aspects of religious belief,
7 observance, and practice and includes agnosticism and atheism.

8 (h) “Sexual orientation” means heterosexuality, homosexuality,
9 or bisexuality.

10 (i) “Victim” includes, but is not limited to, a community center,
11 educational facility, entity, family, group, individual, office,
12 meeting hall, person, place of worship, private institution, public
13 agency, library, or other victim or intended victim of the offense.

14 SEC. 2. No reimbursement is required by this act pursuant to
15 Section 6 of Article XIII B of the California Constitution because
16 the only costs that may be incurred by a local agency or school
17 district will be incurred because this act creates a new crime or
18 infraction, eliminates a crime or infraction, or changes the penalty
19 for a crime or infraction, within the meaning of Section 17556 of
20 the Government Code, or changes the definition of a crime within
21 the meaning of Section 6 of Article XIII B of the California
22 Constitution.
