An act to amend Section 48205 of, and to add Section 49428.15 to, the Education Code, relating to pupil health, and declaring the urgency thereof, to take effect immediately.

LEGISLATIVE COUNSEL'S DIGEST

SB 14, as amended, Portantino. Pupil health: school employee and pupil training: excused absences: youth mental and behavioral health.

(1) Existing law, notwithstanding the requirement that each person between 6 and 18 years of age who is not otherwise exempted is subject to compulsory full-time education, requires a pupil to be excused from school for specified types of absences, including, among others, if the absence was due to the pupil's illness.

This bill would include, within the meaning of an absence due to a pupil's illness, an absence for the benefit of the pupil's mental or behavioral health. The bill would require the State Board of Education to update its illness verification regulations, as necessary, to account for including a pupil's absence for the benefit of the pupil's mental or behavioral health within the scope of this provision. To the extent this bill would impose additional duties on local educational entities, the bill would impose a state-mandated local program.

(2) Existing law requires the governing board of a school district to give diligent care to the health and physical development of pupils and authorizes the governing board of a school district to employ properly certified persons for the work. Existing law requires a school of a school district or county office of education and a charter school to notify pupils and parents or guardians of pupils no less than twice during the school year on how to initiate access to available pupil mental health services on campus or in the community, or both, as provided.

This bill, contingent on an appropriation made for these purposes, would require the State Department of Education, on or before January 1, 2023, to recommend best practices and identify evidence-based, as defined, and evidence-informed, as defined, training programs for schools to address youth behavioral health, including, but not necessarily limited to, staff and pupil training, as specified. The bill would define a local educational agency for purposes of these provisions to mean a county office of education, school district, state special school, or charter school that serves pupils in any of grades 7 to 12, inclusive.

(3) *This bill would incorporate additional changes to Section 48205 of the Education Code proposed by AB 516 to be operative only if this bill and AB 516 are enacted and this bill is enacted last.*

(4) The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that, if the Commission on State Mandates determines that the bill contains costs mandated by the state, reimbursement for those costs shall be made pursuant to the statutory provisions noted above.

(5) This bill would declare that it is to take effect immediately as an urgency statute.

21 SEC. 2. Section 49428.15 is added to the Education Code,
22 immediately following Section 49428.1, to read:

23 49428.15. (a) For purposes of this section, the following
24 definitions apply:

25 (1) “Evidence-based” means peer-reviewed, scientific research
26 evidence, including studies based on research methodologies that
27 control threats to both the internal and the external validity of the
28 research findings.

29 (2) “Evidence-informed” means using research that is already
30 available and has been tested for efficacy and effectiveness. This
31 evidence is then combined with the experiences and expertise of
32 the training program developers to best fit the population intended
33 to be served.

34 (3) “Local educational agency” means a county office of
35 education, school district, state special school, or charter school
36 that serves pupils in any of grades 7 to 12, inclusive.

37 (4) “Youth behavioral health disorders” means pupil mental
38 health and substance use disorders.

1 (5) “Youth behavioral health training” means training addressing
2 the signs and symptoms of a pupil mental health or substance use
3 disorder.

4 (b) The department shall, on or before January 1, 2023,
5 recommend best practices, and identify evidence-based and
6 evidence-informed training programs for schools to address youth
7 behavioral health, including, but not necessarily limited to, staff
8 and pupil training.

9 (c) In identifying one or more evidence-based or
10 evidence-informed youth behavioral health training programs for
11 use by local educational agencies to train school staff or pupils
12 pursuant to subdivision (b), the department shall ensure that each
13 training program meets all of the following requirements:

14 (1) Provides instruction on recognizing the signs and symptoms
15 of youth behavioral health disorders, including common psychiatric
16 conditions and substance use disorders such as opioid and alcohol
17 abuse.

18 (2) Provides instruction on how school staff can best provide
19 referrals to youth behavioral health services or other support to
20 individuals in the early stages of developing a youth behavioral
21 health disorder.

22 (3) Provides instruction on how to maintain pupil privacy and
23 confidentiality in a manner consistent with federal and state privacy
24 laws.

25 (4) Provides instruction on the safe deescalation of crisis
26 situations involving individuals with a youth behavioral health
27 disorder.

28 (5) Is capable of assessing trainee knowledge before and after
29 training is provided in order to measure training outcomes.

30 (6) Is administered by a nationally recognized training authority
31 in youth behavioral health disorders or by a local educational
32 agency.

33 (7) (A) Includes in-person and virtual training with certified
34 instructors who can recommend resources available in the
35 community for individuals with a youth behavioral health disorder.

36 (B) For purposes of this paragraph, “certified instructors” means
37 individuals who obtain or have obtained a certification to provide
38 the selected youth behavioral health training.

1 (d) This section shall be implemented only to the extent that an
2 appropriation is made in the annual Budget Act or another statute
3 for these purposes.

4 *SEC. 3. Section 1.5 of this bill incorporates amendments to*
5 *Section 48205 of the Education Code proposed by both this bill*
6 *and Assembly Bill 516. That section of this bill shall only become*
7 *operative if (1) both bills are enacted and become effective on or*
8 *before January 1, 2022, but this bill becomes operative first, (2)*
9 *each bill amends Section 48205 of the Education Code, and (3)*
10 *this bill is enacted after Assembly Bill 516, in which case Section*
11 *48205 of the Education Code, as amended by Section 1 of this bill,*
12 *shall remain operative only until the operative date of Assembly*
13 *Bill 516, at which time Section 1.5 of this bill shall become*
14 *operative.*

22 *SEC. 5. This act is an urgency statute necessary for the*
23 *immediate preservation of the public peace, health, or safety within*
24 *the meaning of Article IV of the California Constitution and shall*
25 *go into immediate effect. The facts constituting the necessity are:*

26 *Because of the COVID-19 pandemic and its impact on children's*
27 *mental health, it is necessary that this act take effect immediately.*
